Certain investment funds (the “Funds”), related to FMR LLC (on the basis solely of the information available to the Issuer), have submitted a request for registration in the Special List to obtain the increased voting right. Each of the Funds, considered individually, has requested and obtained registration for a number of shares below the relevant threshold of 3% of the share capital. Nonetheless, as of today, the shares for which the Funds have requested and obtained registration collectively represent a shareholding equal to 4.06% of the share capital. The exceeding of the 3% threshold occurred following the registrations carried out on January 7, 2025.
